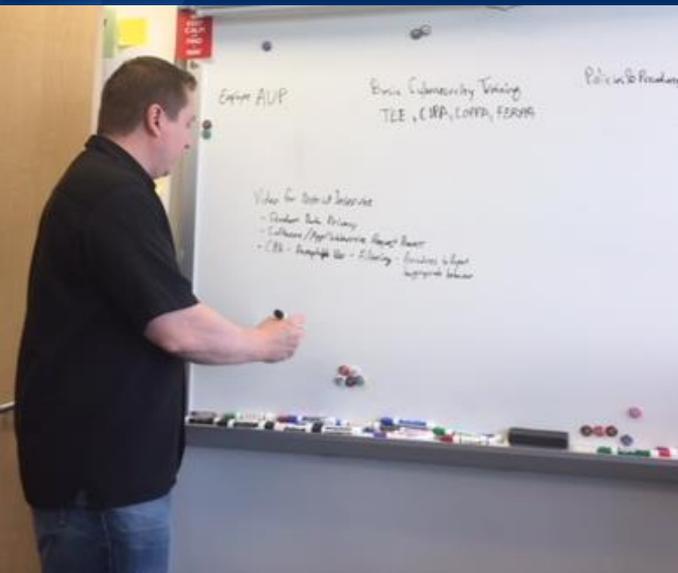




Cybersecurity Continues Moving Ahead and Planning for the Future

As the district plans to move into the Summer School mode, the Cybersecurity team is already looking towards the 18-19 school year.

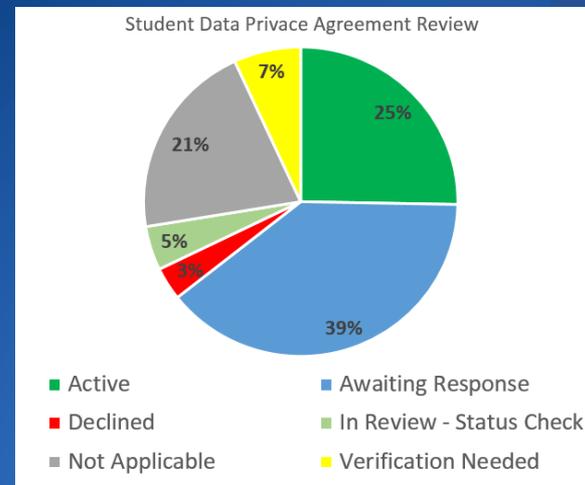
James Costello and **Jennifer Miller** met to review the goals and objectives of the team. This summer will be very busy as they focus on the continue review and enhancement of the following topics:

About TXSPA

Welcome to the Texas Student Privacy Alliance (TXSPA). The TXSPA is a collaboration of Texas school districts that share common concerns around student privacy. The goal of the TXSPA is to set standards of both practice and expectations around student privacy such that all parties involved have a common understanding of expectations.

To this end, the first outcome of the TXSPA is the adoption and implementation of a common Student Data Privacy Agreement to be used by all member schools when implementing any online application. By adopting such a contract all vendors and schools have common expectations when entering into a relationship or implementation without having to renegotiate terms in every new instance.



This site will be used to communicate both the districts and vendors that have signed the contract. This will enable all TXSPA member districts to leverage vendor relationships with other member schools to smoothly develop a new relationship.

As Student Data Privacy Agreements continue to be distributed to current and prospective vendors, **Eric Pina** and **James Costello** have been working with the Access4Learning organization to develop CFISD's application library within the Texas Student Privacy Alliance. Currently, there are **47** vetted applications listed in the database with Agreement Status' of Active, Approved (No Data Collected), or Declined. Cypress-Fairbanks ISD is leading the way for districts in Texas, joining other districts in student privacy alliances from California, Maine, Maryland, Massachusetts, Rhode Island, Virginia, and Washington.
